



# Contemporary Longrifle Association

## 2012 Membership & Show Rules

1. Membership must be current (2012) to gain access to the Annual Show or reserve space at the Annual Show in August, 2012. You will receive a 2012 membership card that will provide you access to the Annual Show.
2. If you were a member in 2010 and did not renew in 2011 you will be required to submit 2011 and 2012 dues to reinstate current membership status and gain access to the 2012 show.
3. Dues - \$50.00 per year. Upon receipt of your dues payment you and your spouse will receive a 2012 CLA Membership Card (white) that will provide access to the annual show for you and your family. (Partner and children will be given a white membership badge at the show.)
4. New Members will be admitted once for a fee of \$20.00 per family which covers membership for the remainder of that year and will receive a pink membership card. **NOTE: IF YOU ATTENDED THE SHOW LAST YEAR FOR THE \$20.00 MEMBERSHIP FEE YOU MUST BE A FULL MEMBER IN 2012 AND PAY THE \$50.00 MEMBERSHIP FEE IF YOU DESIRE TO ATTEND THE ANNUAL MEETING AND SHOW.** Each partner and child will be given a new membership card (pink) and will be admitted only one year at the reduced rate of \$20.00.
5. New members who elect to pay \$50.00 at the show will be given a membership for the next year as well as being admitted to this year's annual meeting and show.
6. **NO ORAL, PHONE OR EMAIL APPLICATIONS WILL BE ACCEPTED FROM ANYONE.** Incomplete applications will be returned to the applicant. THIS SHOW IS A SELL OUT! PLAN EARLY. Exhibitor space from last year will be honored if your application and dues / exhibitor space payment is received by April 1, 2012. Exhibitor space will be assigned based on availability after April 1, 2012.
7. Payments may be made by credit card or check / money order drawn only on a US Bank.
8. Guards will be stationed at each entry point and no admission will be granted unless the member is displaying a membership card that is visible to the guards.
9. Tables not occupied by 10:00 am on Friday will be reclaimed and no refund will be made.
10. Show hours will be published and enforced.
11. Educational displays for awards are encouraged. The exhibitor must register at the admission table to participate in the awards program. The exhibit must be in place at the time an award is presented unless special permission to remove is granted by the show committee.
12. Tables and booths for the contemporary section will be awarded for display of handmade art ONLY. Close attention will be paid to the percentage of each item listed for display.

13. No more than 20% antique items are allowed on a Contemporary Show table and no more than 20% contemporary items are allowed on Antique Show tables.
14. Exhibitors with items on display that do not meet the criteria of handmade from the longrifle culture will be asked to remove them from the table.
15. All tables are required to have a table cover.
16. Exhibitors that do not remain set up until 3 p.m. on Saturday will not be guaranteed a table next year unless hardship permission is granted by the Show Committee.
17. Exhibitors may share a table or booth; however the registered exhibitor assumes responsibility for the table.
18. The Show Committee will make final decisions on all rules interpretation, items allowed and all conduct issues.
19. Attendees will bring any issue that renders concern to the attention of the Sergeant-At-Arms/Show Chairman.

**Scope of Items allowed for Exhibit**

**Tables and booths shall be awarded only to exhibitors who display handmade made art (antique and contemporary) that relates to the longrifle culture. (No black powder, black powder substitutes or explosives allowed.)**
